The School of Kinesiology and Health Studies at Queen’s University invites applications from suitably qualified candidates interested in teaching *KNPE 493 (Advanced Topics in Kinesiology: Critical Research Appraisal in Exercise Physiology)*. This is a fourth year, undergraduate seminar course that will be offered remotely with an expected enrolment of ~25 students. Candidates should have a M.A. or M.Sc. or Ph.D, as well as teaching experience at the University level in a health-related discipline. This is a Fall term appointment for the period of September 1, 2021 to December 31, 2021, with classes in session from September 7, 2021 to December 3, 2021.

The University invites applications from all qualified individuals. Queen’s is committed to employment equity and diversity in the workplace and welcomes applications from women, visible minorities, Aboriginal peoples, persons with disabilities, and LGBTQ persons. All qualified candidates are encouraged to apply; however, Canadians and permanent residents will be given priority.

KNPE 493: Advanced Topics in Kinesiology

Fall 2021 TOPIC ID: Critical Research Appraisal in Exercise Physiology

In this seminar-based course students will use classic and contemporary exercise physiology research to learn how to properly conduct experiments and critically appraise research. Students will work within a specific discipline of exercise physiology of their choosing. This course will explore many topics related to critical research appraisal including study design, methodologies in exercise physiology, and experimental bias. A focus will be placed on how to conduct a systematic review and meta-analysis, and students will leave this course with an appreciation, knowledge, and skillset applicable to future research settings.
